# "Love" Is Not Enough

"What the world needs most is love sweet love." So go the words of one of the current banalities referred to as popular music. Popular, yes; music, no. But when it comes to the matter of religion, man's relationship to an infinite Creator, the hackneyed words are halfway right. Half-way, mind you; not all the way. For human love, however sweet and rewarding, can never solve our problems. It can solve some of them, but never all of them. For love of mankind for his fellow-creatures is only one side of the coin. That "love" is not enough; indeed, it is secondary and inferior to the greater and more encompassing love. Meaning man's love for God.

If love for one another could give the total answer, then surely life would be much simpler and easier for all of us. But it is possible for two people to love one another with a total and consuming fervor, and be completely indifferent, or even antagonistic toward God. Both history and literature are filled with examples of man and women who lived, but whose lives ended in bitter frustration and misery. They loved - but they did not love God. Abouben Adhem wanted to be recorded as "one who loved his fellow men," and Abou's creator wanted to equate that with "love of God." Not so. We cannot love God without loving our fellows, but we most certainly can love mankind without loving God.

All of which has deep significance for those of us who believe ourselves to be children of God. That differences exist among us is obvious. Ignoring them will not remove them; neither will loving one another remove them. Of course, there are some differences that love can resolve, but that's not what we are talking about. Those differences may all be removed completely, and still we may be poles apart.

There is a kind of love, however, which DOES solve our problems — the love we have for God. "For this is the love of God," wrote John, "that we keep his commandments." (I John 5:3.) The man who says he loves God, but does not keep God's commandments has deceived himself. He does not love God; he may have exalted his own opinions and judgments and prejudices to the point

that he is confused as to what are God's commandments. But if that be the case his lack of humility has blinded him. This is probably what has happened in the recent tragic division within the body of Christ. Brethren were so CERTAIN they were right that they gave little time or thought to a careful, diligent, and prayerful study as to just what the will of God was.

Surely the time is long overdue when brethren should sit down together as brethren, lay their differences out for full and frank discussion - not to prove who is right or who is wrong, but to ascertain what can be done by all of them to find and follow exactly the will of God! They may love another and not follow this course; but it is indisputable truth that they cannot love God and refuse to make any effort toward reconciliation. When a man loves God he is automatically and without fanfare or ado in fellowship with every other person on the earth who loves God; when a man does not love God, he is out of fellowship with every person who does love him.

This really is a very simple sort of editorial. It is summed up in the words of Christ to a certain lawyer, "Thou shalt love the Lord thy God with all thy heart. and with all thy soul, and with all thy strength, and with all thy mind; and thy neighbor as thyself." (Luke 10:27.) For too many years it has pretty clearly been demonstrated that the words of Christ, spoken first by Isaiah to ancient Israel, "This people honoreth me with their lips; But their heart is far from me," could be applied with deadly accuracy to a great number of "Church of Christ people" in the twentieth century. When strife and alienation and bitterness exist, when fellowship is broken, when congregations are divided, SOMEBODY does not love

There are two fundamental concepts which, if tenaciously held to, will forever make impossible any division among God's people over a matter of doctrine. They are (1) the absolute authority of God's word, and (2) the fact that God's word is clear enough for men to understand his will. Those two bed-rock principles being accepted totally and

### How They Did It

THE PHILIPPIAN JAILER

Due to the face that Paul was the first preacher mentioned in the New Testament to have gone into Macedonia of Europe, we believe that the jailer knew nothing of Christ. We are to hear the Gospel, believe it, repent, confess Christ and then be baptized to become a Christian. So when this jailer asked, "Sirs what must I do to be saved"?, Acts 16:30, it was necessary to begin at the beginning! Faith comes by HEARING the word of God, Rom. 10:17, so in order for him to have faith, they "spake unto him the word of the Lord", Verse 32. He believed this word, Verse 34. He repented, did the works of repentance, Verse 33. Then he was baptized, Verse 34, which is for the "remission of sins" Acts 2:38.

THOSE IN ACTS 2

In the second chapter of Acts there were "Jews and proselytes out of every nation under heaven", Verses 5-10. These had come together to keep the feast of Pentecost which was authorized under the law of Moses. These had crucified Christ, therefore did not believe him to be the Son of God. The apostles preached to them that they did believe, and be-lieving, asked, "Men and Brethren what shall we do"?, Verse 37. These BELIEVING Jews were told to, "Repent and be baptized every one of you in the name of Jesus Christ for the remission of sins, and ye shall receive the gift of the Holy Spirit," Acts 2:38. Jesus said that this would be preached, beginning at Jerusalem, Luke 24:46-47. The Holy Spirit instructed the apostles to preach this. Acts 2:4. Those who were baptized were added to the church, Acts 2:47. SAUL, OR PAUL

Saul thought that he ought to do many things, that he later learned were contrary to the commands of Jesus, Acts 26:9-11. Though he had a clear conscience, he still was wrong, Acts 23:1. Jesus appeared to him that he might be an apostle and believe in him, Acts 9:3-6. One had to see Christ to be an apostle, Acts 1:21-22; 1 Cor. 15:8. Saul was told to go into Damascus and THERE it would be TOLD him what "thou must DO", Acts 9:6. While he waited for these instructions, what he MUST DO, he spent the time in PRAYING and FASTING (three days),

Let us hope that men of good will may yet find a way out of the debacle. Maybe an occasional edition of "ACTION" such as this one can make a contribution in that direction. At least it ought to help a little bit to encourage more "love of the brethren" and that is one step toward the ultimate necessity for unity-love of God.

By Glynn Purdy IS IT OK TO DRINK COFFEE WITH THOSE WHO ARE NOT CHRISTIAN?

The Christian MUST associate with those who are NOT Christian, in order to convert them. Jesus was condemned by the Pharisees for His association with "sinners" and He responded that "the sick" (sinners) "need the physician." Matt. 9:10-12. Jesus was the great "Physician", but he must contact those whom He "healed". Of course the Christian is not to "partake of the sins of the world, I Cor. 15:33, and he is not to be "unequally voked" with them, 2 Cor. 6:14. But as the "light of the world" and the "salt" to save, he MUST come in contact with the "unbelievers" in order to "show" and "teach" them of Jesus. So, YES INDEED, it is not only "right" but one must take every opportunity to associate with those of the world, not be be led by the world, but to lead the world to Christ. The Christian is not to be "like" the world, but to make the world "like" Christ, Romans 12:2.

SHOULD A PERSON FAST TODAY?

# Answering Some of Your Questions (Cont.)

MORE ON THE 430 YEARS THE ISRAELITES SPENT IN EGYPT.

FROM THE CALL OF ABRAHAM, TO THE GIVING OF THE LAW OF MOSES, THERE IS ONLY 430 YEARS! From the best authorities, Abraham was born in 1996 B.C. was called at age 75 (1921 B. C.), and 430 years later (1491) the law of MOSES was given. So we can count from NO OTHER DATE! The King James speaks of the covenant being "confirmed" which leads some to think that the 430 years should begin from the time God "confirmed" the convenant with Jacob, but there is NOT this much time to account for here. The New English Bible makes this plain. "A testament, or covenant, had been validated (instead of "confirmed", with Abraham of course GVP) by God; it can not be invalidated, and its promises rendered ineffective, by a law made four hundred thirty years later," Gal. 3:17. If you will notice in Gen. 12:1, that God is "confirming" a covenant that he "had" made with Abraham BEFORE this is repeated in Gen. 12:1. It states that God "had said unto Abram" (past tense) and it is here CONFIRMED. So from this "confirming", when Abram was 75 years of age, we MUST begin our 430 year count which I did in the article which appeared in the REVEALER. If you have it, read it again!

# Why Didn't the Lunar Module Sink?

Uniformitanianists were predicting that when the lunar module landed on the moon it would sink into miles of dust. Why did evolutionists think there was so much dust on the moon? Because 14.300.000 tons of meteoritic dust settles on the earth each year. (Henry M. Morris and John C. Whitcomb, Jr., The Genesis Flood, page 379) If the earth were five billion years old there would be layer of meteoritic dust fifty-four feet thick on the entire surface of the earth. Since there is no such layer of meteoritic dust on the earth, uniformitanianists say that this layer of dust cannot be detected because it is assimulated by the plants and dissolved by the seas of the earth.

But since there are no plants and no seas on the moon, they were sure that the fifty-four foot layer of meteoritic dust would be found on the moon. But it wasn't there. The lunar module sank in only about two inches of dust and hit solid rock.

- 5. The Scriptural Test: Does the Bible endorse it, or is it expressly forbidden by the Word of God?
- 6. The Stewardship Test: Will my doing this constitute a waste of the talents God has given me?
- 7. The Missionary Test: Would I have the proper influence over others whom I should bring to Christ?
- 8. The Character Test: What will be the influence on my moral and spiritual stamina?
- 9. The Family Test: Will it bring discredit and dishonor to my family, will it embarrass them?
- 10. The Publicity Test: Would I be willing for friends, fellow-Christians, the elders and the preacher to know about it?

Acts 9:9, 11. This is ALL he knew to do. So he had BELIEVED and REPENTED, we know by his deeds. So when the preacher, Ananias, whom God sent to tell him what he MUST DO, arrived, knowing that he believed and had repented, he told him this, "And now why tarriest thou? Arise, and be baptized, and wash away thy sins, calling on the name of the Lord," Acts 22:16. He still had his sins, even after believing, repenting, fasting and praying, for they STILL needed to be "washed away" in baptism, for Jesus said that "He that believeth AND is baptized shall be saved," Mark 16:16. 3. I am advanced in age. (She was 73 years of age)


4. I do not believe that I am able to go. (She had been under treatment for heart condition)

## Lord's Supper

Observed Annually, Semi-Annually, Quarterly? When?

At the institution of the Lord's Supper, Jesus stated that the Supper was to be observed in His Father's Kingdom (Matt. 26:26-29). We know that the Kingdom and Church are synonomous terms. Jesus said, "Upon this rock I will build my church" (Matt. 16:18). In Matt. 16:19 we read, "... and will give unto thee the keys of the kingdom." Thus, the Lord's Supper is to be observed in the kingdom or church (Lk. 22:30) and since Christians make up the church or kingdom, the Lord's Supper is to be observed by Christians only. Today this is not a disputed fact among religionist, but is commonly accepted.

The disputed question is: "How frequently do we observe the Lord's Supper?" By letting the Bible be our only guide, I think intelligent people can see the Lord's intention of its observance.

I Cor. 11:20, "When therefore ye assemble yourselves together..." Heb. 10:25, "Not forsaking the assembling..." These verses point out a customary event of assembling by the disciples. Question-How often was this assembling? Answer-"Upon the first day of every week' (I Cor. 16:2 RSV, NASB, TEV). What was the purpose of their assembling on Sunday? Acts 20:7 points out the purpose, "Upon the first day of the week when the disciples came together to break bread," ("to break bread" is an infinitive of purpose). "To break bread" is parallel to the Lord's Supper. For us to observe the Lord's Supper in the 20th century like our counterparts of the 1st century, we scripturally observe it each first day of the week.
